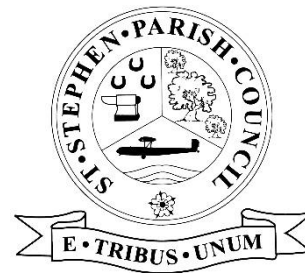

The developers presented proposed changes to the existing planning permission before the planning committee meeting. Currently they have permission for 200 units and plan to increase this to 232 homes, with a reduction in the numbers of 5 and 4 bed units and increase in 2 and 3 beds. The ratio of affordable housing will be maintained at 35% with the majority being social rented accommodation and other intermediate ownership whereby the property is part rented part owned. The application will be made in the next few weeks.
